Membership Agreement Taekwondo Team Saja UTA

These terms and conditions form an agreement (referred to in this document as 'the agreement') between:

- You; and
- Us, Taekwondo Team Saja UTA (represented by Fabian Burkhardt)

You must keep to all of the terms and conditions of the agreement.

1. Start Date and Membership

- a) Your membership will start on the date this membership agreement is signed.
- b) There are three parts to the membership:
 - i. A membership license issued by British Taekwondo (BT) that covers your insurance during training and all BT-affiliated events. The BT membership is a requirement for every participant, regardless of the Taekwondo Team Saja membership they choose (excluding honorary members).
 - ii. A membership issued by the United Taekwondo Association (UTA). The UTA is a subsidiary association of clubs within BT. All UTA events are sanctioned and insured by BT. The UTA membership is a requirement for every participant, regardless of the Taekwondo Team Saja membership they choose. (excluding honorary members).
 - iii. The TTS club membership fee for classes and other events held by Taekwondo Team Saja UTA.

2. Membership Options and Length

The following section will detail the length of the BT/UTA license as well as the membership types offered by Taekwondo Team Saja:

- a) The BT and UTA memberships are valid for one year from the point of purchase and have to be renewed yearly thereafter. The combined price for these licenses is £30. This fee is subject to changes made by BT/UTA.
- b) Taekwondo Team Saja offers the following membership options:

i. Monthly membership - £15/month

The monthly membership is our most flexible option. Your membership will automatically be renewed every month. This membership can be started at any point during the year. To end this membership a written cancellation must be requested no later than 7 days before the start of the new month. The request must be sent to <u>finance@taekwondosaja.com</u>. Failure to request the cancellation in time, or sending it to the wrong e-mail address will result in a new invoice being issued and payment for the following month being required.

ii. Online membership - £5/month (only during government enforced restrictions)

In the event of government-restrictions that will not allow us to train in person, we will switch to digital training on Zoom (or similar). We will continue to offer training at the same times as before using an online platform. In such an event, all memberships will automatically be switched to online, and our members will be refunded the difference (for the duration of the restrictions) if they wish. This membership will only be used if in-person training is not permitted due to government guidelines.

iii. Discounts

We offer 20% discounts for every additional family member if you have one fullpaying member. All university students with a valid student ID will also receive a 20% discount. Please note that the discounts can only be applied to our TTS memberships and <u>NOT</u> the BT & UTA membership.

3. Paying Membership Fees

<u>Membership fees must be paid within two weeks (14 days)</u> of joining Taekwondo Team Saja. The joining date is the date this agreement has been signed. If a payment by invoice or payment link were requested, the fees must be paid within 14 days of receiving the invoice/payment link. *Failure to pay within 14 days will result in the termination of your membership.*

Change your mind? No problem. If you let us know in writing within the first 7 days, we can reverse your payment. After this time it is unfortunately not possible and out of our control.

Payments can be made by bank transfer (see below), pay by card, invoice, PayPal or payment link by phone. All payments except bank transfer are handled securely and are protected by Zettle[©], a subsidiary of PayPal.

4. Notices

All official communication from the club will be handled using secure e-mail accounts ending in *@taekwondosaja.com*. Common prefixes include <u>info@taekwondosaja.com</u> or <u>finance@taekwondosaja.com</u>. Please do not respond to financial queries from any e-mail address other than <u>finance@taekwondosaja.com</u>.

As we are trying to be a digital club, we do not receiving printed mail. Membership cancellations are only accepted in written form in an e-mail sent to <u>info@taekwondosaja.com</u> or <u>finance@taekwondosaja.com</u>.

5. Increasing Membership fees

Once you have signed your membership agreement with us, we will not change the pricing at any stage during the membership. All memberships automatically end on the 31st of August every year and must be renewed thereafter.

We might be forced to increase the membership fees if the facility hire or other club expenses change. These costs will be communicated beforehand and will only be applied to new memberships starting on the 1st of September 2023.

6. Us Ending Your Membership

- a) Ending the Agreement Immediately
 We may end your membership and your agreement immediately by giving you written notice if any of the following applies.
 - i. Any amount you owe under the agreement is overdue by more than two weeks from the date it was due.
 - ii. You, any guest of yours, or any member whose membership is linked with yours, uses rude, obscene, abusive, threatening or violent language, or behaves in a rude, obscene, abusive, threatening or violent way towards anyone at the club at any time.
 - iii. We receive or have received complaints about you in connection with your use of the club so that, in our reasonable opinion, ending your membership is in the best interest of other people who visit and utilise the club.
 - iv. You do not keep to the conditions outlined in this document.
 - v. When you applied for membership, you gave us details which you knew were false, and/or those details affected our decision to accept your application.
 - vi. You do not keep to the Bribery Act 2010, Equality Act 2010, Modern Slavery Act 2015 or Counter-Terrorism and Security Act 2015.
 - vii. You misuse Taekwondo-related knowledge inside or outside of training. Your misuse of Taekwondo, particularly towards other people, without the need for self-defence, will result in immediate termination of your membership. We

reserve the right to inform British Taekwondo and or the Police of such behaviour, if we see fit.

If we cancel your membership under this clause, you will not be entitled to any refund relating to the period of time when, because your membership has ended, you cannot use the club's services.

b) Ending the agreement after giving notice

We can end your membership and the agreement at any time if we give you at least three calendar months' notice in writing. If we cancel your membership under this clause, we will, within 14 days from the date your membership ends, refund the proportion of the membership fees you have paid for the period of time when, because your membership has ended, you cannot enter the club or use the facilities you have signed up for. One such case could be the closure of the club.

7. Underage Members

This clause applies if a parent or guardian signs this agreement on behalf of an underage member. The signee of this form guarantees, on behalf of the underage member, that they will keep to the terms and conditions set out in this agreement and pay all fees on their behalf.

8. Changes of this agreement

If you need to adjust any parts of this agreement, please talk to the instructors. Changes will be dealt with on a case-by-case basis.
